I/we, for myself and/or any minor participant, my personal representatives, heirs and my next of kin acknowledges, agrees, and represents that I/we have, or will immediately upon entering said restricted areas, inspect said areas and warrant that if, at any time I/we is in or about any restricted areas and I/we feel anything to be unsafe, I/we will immediately advise the officials of such and will leave the restricted areas.

I/we, for myself and/or any minor participant hereby release, waive and covenant not to sue and discharge the promoter, participants, Winchester Speedpark LLC/ WSP Holdings LLC or any subdivision thereof, track operator, officials, any persons in restricted areas, sponsors, advertisers, owners and lessees of premises used to conduct the event, and each of them, their officers and employees, herein referred to as "releasees" from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damages and any claim or demands therefore on account of injury, including death, to my person or property whether caused by the negligence of the releasees or otherwise while I/we is in or upon the restricted areas and/or competing, officiating, observing, working for or for any purpose participating in the event.
