I/we, for myself and/or any minor participant, my personal representatives, heirs and my next of kin acknowledges, agrees, and represents that I/we have, or will immediately upon entering said restricted areas, inspect said areas and warrant that if, at any time I/we is in or about any restricted areas and I/we feel anything to be unsafe, I/we will immediately advise the officials of such and will leave the restricted areas.
